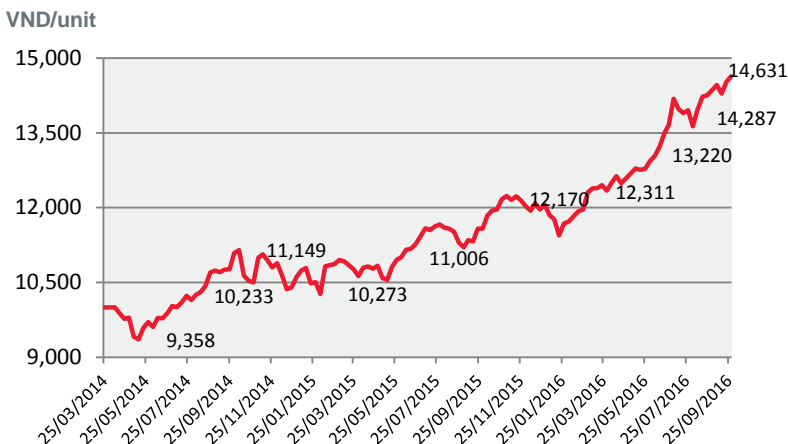

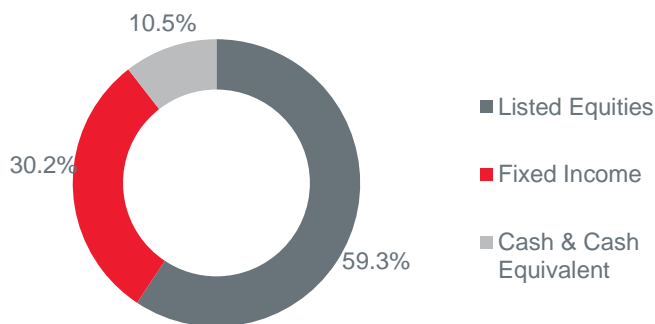
PERFORMANCE CHART – NAV
